The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (17.03.2015) along with the Council Assessor's Report (April, 2014) and Compliance dated 25.10.2014 submitted by the College Authorities and decided to recommend to the Central Government that MD/MS (Opthalmology) qualification against increased intake from 06 to 12 seats granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Aravind Eye Hospitals, Madurai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
